Bill called the meeting to order at 6:07 pm. Bill read an email from Bob Hardesty that he has appointed Michele Giarusso as Assistant Town Clerk while he recuperates.

There was much discussion on the wording to transfer the \$120,000 and \$18,500 in state grant money for broadband.

**Motion:** Jeff moved to transfer \$120,000 plus \$18,500 from state drop cost money to the Enterprise fund for FY22 for broadband debt. Bill 2<sup>nd</sup>. Unanimous.

Historical gift account this was discussed at last week's meeting.

**Motion:** Jeff moved to establish a gift account under Chapter 44 section 53A for the Historical commission. Bill 2<sup>nd</sup>. Unanimous.

Select board Discussed closing out the septic system account as it has been inactive for several years and this was a recommendation when Tom Scanlon conducted the audit earlier this past fiscal year. This money should revert to free cash next year.

**Motion:** Jeff moved to close out the septic system account for \$82,000. Bill  $2^{nd}$ . Unanimous. **Special town meeting discussion.** 

Select board read over all warrant articles. It is ready for posting as soon as Michele can complete the recommendations under each article. Michele will call a constable to post.

**Motion:** Jeff moved the Special town Meeting warrant articles as written. Bill 2<sup>nd</sup>. Unanimous. **Annual Town Meeting budget and warrant articles**- Ginger handed out a spreadsheet on the stipends that Finance Committee is recommending. Select board stated they would like to be in alignment with the Finance committee. Selectboard will discuss at their next meeting. Both boards finished going through the budget and warrant articles. There was discussion on a police cruiser whether it should be leased or purchased. Michele G. stated she put in for a grant for the police as instructed by the selectboard but has not heard from the state authorizing body, she will email them this week. Ginger

**Municipal Assistant-**Michele presented to the board an invoice for \$2500 from Kuzmeskus busing to deliver meals to Leyden children through the summer. She stated this could come out of the Cares Act. Also, the FRCOG has sent a bill for contact tracing in Leyden and this also can come out of the Cares Act. Annual Report will be ready to go to the printer electronically this week.
